Honorable Judge Voorhees,

We are writing to you from Munich, Germany re the court case of Bernard von NotHaus whose case you are about to decide upon soon. I am the co-founder of not-for-profit organization "German Precious Metal Society" [GPMS / DEG e.V. www.edelmetallgesellschaft.org].

This NGO was founded in 2006 with the main purpose of promoting gold and silver as basis of "good money". The sole monies in the world that exist completely naturally – i.e. without a need for "legal tender laws". It is especially since 2008 that we steadily gain more and more supporters for our DEG-society and for the cause of sound money which we promote by means of public events (approx. 50 to date), widely read articles in magazines, and a popular internet blog with associated discussion groups on "real money". The main reason for this huge increase in membership and support have been the financial crises in first the US and currently in Europe – which more and more people rightfully attribute to and blame on our unbacked "fiat" money system. Many people strongly believe that crises like these would not have been possible had the US Dollar (und in turn all other world currencies) not been debased August 15, 1971 by the unfortunate act of de-coupling the Dollar from gold. It is our conviction that the world would have been better off had Nixon kept the link to gold – thereby sticking to gold as natural money – and also the constitutional money according to the US constitution / Section 10.

Some people might argue that in the narrow meaning and wording of US-laws Bernard von NotHaus might have infringed some "branding rights" of a central bank by using the term "Dollar". However, to our knowledge, it is not illegal to use the word "Dollar" in the US (or in Canada, Australia, Singapore, Hong Kong etc.).

In any case, we fail to recognize any damage von NotHaus has done to anybody; or any harm he has done to the spirit of the US constitution or to nature by emitting silver medallions as money. In most countries it is perfectly legal to fabricate private medallions made from gold or silver or otherwise. Gold and silver coins/medallions are natural money by their very nature and have been for 5000 years, even if they do not bear a mark called "US-Dollar" or "Canada-Dollar" or "Euro" or "Rand" or "DeutscheMark". In fact — up until 1914 (when

Germany and basically all developed nations emitted coins made from precious metal) it was almost unnecessary to print a number or a denomination on the coin (e.g. "2 Gold Marks") – because people were interested *only* in the weight and fineness of the coin. An ounce of pure silver or gold had a certain purchasing power – completely regardless of the currency's name, the number printed on the coin and of the respective monarch's face on it. It was only after 1914 (and finally after 1971) that gold/silver monies were demonetized. The world was more peaceful before 1914 than afterwards...

We are certain that Bernard von NotHaus did not have any criminal intent by offering natural money to US-citizens. Actually we do not even believe (without knowing it for sure) that the emission of "Liberty Dollar" medallions with a face value close to or identical to the material value would have been a good "business case" for Bernard von NotHaus. It is therefore even doubtful that he expected to make a profit. Similar organizations here in Europe all work on a not-for-profit basis – most of them exist for purely altruistic reasons and certainly without any criminal intent!

For all these reasons we ask you for a *very* mild sentence for Bernard von NotHaus, *if any at all*. For our members of DEG-e.V.-NGO he is definitely not a criminal but someone with a good and altruistic feeling for history and gold/silver as natural money. People like him should not be in prison.
